CHINESE PREREQUISITES:

- Chinese Language and Cultural minor is for students who start with zero or a little knowledge of Chinese language and culture.
- Chinese Literature and Culture Minor is for students who have completed Gr.12 Mandarin or students who have equivalent knowledge of Mandarin.
- With permission, students minor in Chinese language and culture can take any two of these upper level
- (CHIN401, 402, 311,312, 322, 321, 411 or 412) Chinese courses.

➤ **A total of 24 s.h. of credit, including a minimum of 12 s.h. of upper-level credit is required to complete a Minor. A minimum overall (cumulative) GPA of 2.00 is required for graduation.**

➤ **NOTE: In order to be eligible for graduation you must complete an Application for Graduation via the Student Portal and submit a completed checklist to the Office of the Registrar by April 30 of the year prior to your completion (there is no fee to apply for graduation). Once your complete application has been received, a degree audit will be completed for you. This audit will confirm which courses are still outstanding in order for you to complete your degree.**
